PROJECT HSE POLICY

PT BORNEO MITRA SINERGI-Project Management of CONSTRUCTION SERVICES will exert efforts to develop, implement, maintain and continually improve Health, Safety and Environmental programs dedicated for successful and safe accomplishment of the Project. For this purpose:

- Project Management will apply and communicate BMS and Client's HSE Policies to all workforces.
- We will meet HSE compliance with all applicable laws, regulations, and standards; we will also meet HSE requirements prescribed in Contract of "Construction Services" and HSE regulation within Client territories.
- o No person under BMS control will be employed without pre-work examination that covers skill, competence, and medical.
- o No person under BMS control will be allowed to enter project site without safety induction and PPE.
- o We hold strongly that safety must be rule number one in every works and we are accountable for ourselves and the safety of others in the workplace.
- o All project employees indiscriminately shall obey HSE rules, regulation, and procedures established for this Project. Any disobedience will be sanctioned.
- No work will ever be done without a pre-job risk assessment and a safety talk appropriate for the level of work; and – as prescribed in Contract or related to Client's HSE regulation – no work will be executed without Permit to Work and/or other approved documents.
- All person will be trained and must be competent to execute the works he responsible for. No work will ever be permitted to be performed by person who is not competent and/or not authorized for.
- o Project works must be performed in an atmosphere of trust, discipline, openness, and cooperation between workforces and with subcontractor.
- o HSE officer has right to hold and stop work due his judgment.
